*Since 2000, as I became a full professor, I have focused my research and main fields of expertise on Media and information Literacy, Digital Literacy, Education for Global Citizenship, Internet Governance and Cultural diversity. I have also developed a responsible professional experience in operational management and partnerships, with more than 10 years at a leading managerial level, national and international. I have acquired a recognized experience in leadership and have a proven ability in planning and managing international projects or programmes, especially with academia and civil society organizations (IAMCR, ECREA) and intergovernmental agencies (Council of Europe, European Commission, OIF and UNESCO).*

*Since 2015, I have been head of UNESCO chair "Savoir Devenir in sustainable digital development: mastering information cultures" and since 2017 president of NGO Savoir\*Devenir, attached to the chair. I conducted relevant work with international agencies, non-governmental organizations, private sector companies and high-level experts. I conducted more than 12 international projects, attesting to a recognized experience in leadership and a proven ability in planning and managing international programmes. These projects are connected to my research fields, Media and Information Literacy, Media Development, Cultural Diversity. The NGO Savoir\*Devenir systematically applies research-action and research-intervention with implementation and scaling up of resources, competence frameworks and best practices.*

*From 2013 to 2015, I was director of CLEMI, the French operator for Media and Information Literacy. I was responsible for its pre-configuration and restructuration. During my mandate, I had to deal with the terrorist attack against Charlie Hebdo and had to run emergency programmes for the Ministry of Education in the aftermath of the "je suis Charlie" movement, in January 2005.*
